### Copyright clearance

For all living artists – or those who died less than 70 years ago – there will be a separate copyright in the work itself (in addition to our copyright of the digital image file / photographic reproduction). This may entail a separate copyright charge due to the artist or artist's estate.

It is the client's responsibility to obtain permission from the copyright holder or their agent before a reproduction of any work or content is made, or this will constitute an infringement of copyright.
